2. on your intended license server, execute rlmutil/rlmutil.exe which was installed in the above step (on windows, you may find it helpful to run rlmutil.exe from the command line)
  - rlmutil rlmhostid
  
3. Capture the full output of rlmutil rlmhostid, **print and attach to this order** form before submitting
